#### **Article 1 - Purpose**

### Article 3 – Obligations of the parents

The parent(s) agree to:

- 1. Enroll the child(ren) named above at Ecole Internationale du Savoir les Emeraudes for the 2025-2026 academic year.
- 2. Acknowledge and adhere to the school's educational project and internal regulations, ensuring compliance by their child(ren).
- 3. Be aware of the tuition fees and commit to their payment under the conditions outlined in the attached financial addendum.
- 4. Notify the school promptly of any changes in their family situation.

#### Article 4 - Parents' contribution

Parents' cooperation is particularly required on the following points:

- 1. Attending mandatory parent/teacher meetings (representation by nannies, private tutors, drivers, or other escorts is not permitted).
- 2. Complying with the school rules (as described in the parent handbook).
- 3. Informing the administration and teachers in case of absence.
- 4. Ensuring punctuality and regular attendance.
- 5. Understanding the school's right to review a student's acceptance under the following circumstances:
- If the school deems it unable to meet the child's educational, social, or emotional needs.
- If parents demonstrate a lack of cooperation with the teaching team, jeopardizing the child's progress and harmonious development (e.g., systematic absence from meetings, no assistance with homework, persistent tardiness or absences, disregard for school rules, ignoring recommendations, or withdrawing the child from remedial classes).
- 6. Accepting that in cases of learning difficulties, the school may request an expert evaluation if internal resources prove insufficient. Parents will be responsible for organizing and funding such evaluations.
- 7. Committing to continuous engagement with the school, as education from Nursery to year 6 is both a social and academic activity.
- 8. Volunteering to support the school's activities (participating in one or two events, competitions, or other initiatives).
- 9. Understanding that tuition fees do not cover all needs; additional contributions may be requested (e.g., for field trips, museum visits).
- 10. Respecting the school's facilities and property.
